  - Computational text analysis project that is collecting textual data about public discourse on the humanities and analyzing it using digital methods. My technical contributions to the project include writing Python scripts for interacting with the LexisNexis API, cleaning our data, and importing it to our database; implementing various topic modeling and text classification algorithms in our Jupyter notebook environment; and applying best practices in data curation and management.

  - A system for exploring the humanities that encourages users to seek out relationships between authors, works, and commentators – both living and dead – as part of a social network of knowledge. It presents bibliographical information as an interconnected network of evolving relationships between documents and people. RoSE allows users to add items to the network, create and visualize their own collections, and produce “storyboards” to visually organize their findings into meaningful arguments or narratives. I managed the project team and lead the project's human subjects research.
